	Hysbysodd y Clerc y Cyngor fod Adroddiad yr Archwilwyr Mewnol ar gyfer y flwyddyn yn diweddu 31 Mawrth 2026 wedi'i ddychwelyd a rhannwyd hwn gyda'r Cynghorwyr. Ni chodwyd unrhyw faterion na'u dwyn i sylw'r Cyngor i beri pryder. Esboniodd y Clerc hefyd y ffigurau a amlinellir ar Dudalen 1 o'r Ffurflen Flynyddol. Cynigiwyd ac eiliwyd (AS/MD) a chytunwyd yn unfrydol i dderbyn yr adroddiad a chymeradwyo'r Ffurflen Flynyddol a'r Datganiad Llywodraethu Blynnyddol ar gyfer 2025/2026. Diolchodd y Cynghorydd Mr Myfyr Davies i'r Clerc am ei holl waith caled a chymeradwywyd hyn gan yr holl Gynghorwyr eraill a oedd yn bresennol.	The Clerk informed Council that the Internal Auditors' Report for the year ending 31 st March 2026 has been returned and this was shared with the Councillors. There were no matters raised or brought to the Council's attention to give cause for concern. The Clerk also explained the figures outlined on Page 1 of the Annual Return. Bydd y Clerc hefyd yn e-bostio copi o bob dyfynbris i sylw pob Cynghorydd cyn cyfarfod nesaf y Cyngor ym mis Gorffennaf a bydd yr eitem ar y rhaglen er mwyn gwneud penderfyniad. Rhaid gwario'r arian cyn diwedd mis Hydref 2026 yn unol â meini prawf y gronfa.	Following the decision made at the last meeting, the Clerk informed Council that he has received 3 quotations to purchase 5 Speed Awareness signs to be located in Malltraeth (2), Hermon (1) and Bethel (2). The Clerk will now complete the application that will include the 3 quotations before the 30 th June 2026 criteria deadline. The Clerk will also email a copy of each quotation to every Councillor before the next Council meeting in July and to place the item on the agenda for a decision to be made.
